1.Introduction

• Social movements make theory that we need to take seriously. Based on a critique of the Cartesian epistemologies of the north, and literature on social

movements as important learning spaces (Arribas Lozano, 2018; Casas-Cortés et al., 2008; Choudry & Kapoor, 2010; Cox & Fominaya, 2009; Della Porta & Pavan, 2017; Eyerman & Jamison, 1991; Foley, 1999; Freire, 2000; Grosfoguel, 2013; hooks, 1991, 1994; Horton & Freire, 1990; Levkoe et al., 2018; Mignolo, 1999; Santos, 2018; Shiva, 2016)

"When our lived experience of theorizing is fundamentally linked to processes of self-recovery, of collective liberation, no gap exists between theory and practice." (hooks, 1991, p. 2)

4. Results: KPL's Theory on Prefiguration

Living the future, we need and want, today

- The KPL's Prefigurative praxis around agroecology and gender equity
 - Motivated by *need*, e.g.: growing enough food, fighting gender-based land grabbing, access to seeds, avoiding debt spirals.
 - *Survival pending revolution*. Prefiguration from a classed, gendered and (neo-)colonial perspective
- *Leading by example:* Prefiguration is an important teaching tool. People can see that a new world is possible and better
- The KPL's praxis is *revolutionary intercommunalism*, fighting the *reactionary intercommunalism* of the patriarchal, neo-liberal, neo-colonial economy.
